## REG; PANEL OF APPROVED VALUERS OF OUR BANK

With reference to your application for empanelment as valuers of the Bank, we are pleased to inform you that vide our R.O. Letter No. RO/REC/GEN/2420 dated 31st March 2005, your name has been included in the panel of valuers in our Bank. a) Valuation upto Rs. 50,000/-	-0.5% of the value

d) Rs. 50,00,001/- to 1 crore	-0.0625% of the value subject to value of Rs. 10,000/- whichever is lower

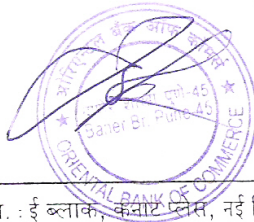
